FAQs:

What do you mean by 'stretched' funding?

Whilst the Government provide 15/30 hours of free childcare, these hours do not cover standard school holidays (38 weeks). Some early years settings charge parents the full unfunded rate for school holidays however, at Berkhamstead Day Nurseries we 'stretch' the funding to include school holidays.

For 30 hours of free childcare, parents are then given a weekly allocation of 22.35 hours to be taken during normal periods and the holidays (11.18 for 15 hours of funding).

Am I eligible for Government funding?

From September 2025, all eligible working parents of children aged nine months up to four years will be able to access funding for 30 hours per week of education and care for 38 weeks of the year. If you are not eligible for this funding, 15 hours childcare for all families in England for children aged 3 to 4 years will remain.

Can I pay using childcare vouchers?

Tax-free childcare is a government scheme to help eligible working parents with the costs of childcare. In simple terms, for every £8 paid into a tax-free childcare account, the government tops it up with an additional £2.

- i. Sessions run in 5-hour blocks; Mornings (8:00am to 1:00pm) and Afternoons (1:00pm to 6:00pm).
- ii. Prices listed above are estimated and may differ to the monthly invoice.
- iii. Please note that for parents new to the Day Nursery for the Summer term, you will only see the funding applied from your May invoice as funding for the Summer term is stretched from May to August rather than April to July.
- iv. Agreed Additional Services Charge (optional): At Berkhamstead Day Nursery we take pride in offering exceptional provision for the Early Years Foundation Stage. The local authority funding rate set by Department for Education is only intended to cover the statutory requirements. The optional agreed additional services charge covers the following additional items:
Meals & snacks: Nutritious meals prepared onsite by our excellent catering team; hot lunches, breakfast/morning snacks and tea.
Consumables: Nappy sacks (for nappies/soiled clothing) and special waste bags. Additional arts and craft equipment/supplies (outside the statutory requirements) will also be provided. This provision therefore requires funding beyond that offered by the Early Years Funding to ensure we can deliver this exceptional service and care. A breakdown of the optional additional services charge can be seen above. Please note these are calculated on average.
Activities: Subject-specialist teaching including Music and French from staff at the school, alongside additional activities such as forest school, library visits, trips to use the School's Early Years gym, astro-turf and cookery room (all dependent on the setting/day that your child attends).
